OFFICIAL RULES

Sweepstakes begins on 11/5/07 and ends 12/3/07.

1. **NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.** There is no cash or exchange value for prizes, and prizes are not transferable. Void where prohibited by law.
